## A. Newton Falls Village Comprehensive Plan

Mr. Kobak reported that the Newton Falls Village Comprehensive Plan is now complete and the Newton Falls Planning Commission unanimously recommended the final draft plan at its November 4, 2014, meeting to the Village Council. He stated that the Village Council met on November 17, 2014, and voted to approve the plan but the legislation does not take effect until two readings and 30 days have expired. He said that the second reading took place on December 1, 2014, and the ordinance to approve the plan will take effect on December 31, 2014.

# B. Champion Township Comprehensive Plan Update

Mr. Kobak reported that the staff continues to redesign the draft concepts for an 80-acre parcel on State Route 45 north of Center Street and just south of Champion High School and work continues to complete the draft comprehensive plan. He stated that the staff created a preliminary draft of the future land use map and conducted fieldwork to either confirm or adjust their ideas. Mr. Kobak stated that the future land use map is the main element in the plan section and provides the basis for implementing the township's zoning.
