B. Champion Township Comprehensive Plan Update

Ms. Nuskievicz reported that the staff met with Champion school board members on October 29, 2014, to discuss the school board's plans in Champion Township. She also stated that the staff created a preliminary draft of the future land use map and conducted fieldwork for this plan. She said that work continues in order to complete the draft comprehensive plan by January 2015.

C. HOME Program

Julie Edwards reported that the Warren-Trumbull HOME Consortium received the award letter for the 2014 fiscal year. She stated that the staff anticipates this funding will be able to complete three down payments and two home rehabilitations.

D. Enterprise Zone

Mr. Zigmont reported that Reinforcement Systems, Inc./Van Merksteijn USA, LLC has requested an assignment and transfer of the Enterprise Zone Agreement dated July 15, 2009, to Engineered Wired Products, Inc., He said that Engineered Wired Products, Inc. is purchasing the facility. Mr. Zigmont stated that all terms and conditions of the original agreement will remain including retaining the 60 jobs that are currently at the facility.

A. Plats and Zoning Committee - Lewis Kostoff, Chairman

VII. RESOLUTIONS FOR ADOPTION - Continued:

Buckeye Civil Design. Mr. Gonda and Atty. Masternick both stated that the Planning Commission should grant the requested variances from the Trumbull County Subdivision Regulations that states that there shall not be more than one residential home on a single lot and from the road construction standards for the access drive since approval from the Hubbard Township Zoning Department and the Trumbull County Health Department for this request have been granted. They also stated that the variances should be allowed since Mrs. Mayfield is a widow and her son wants to build a home near her on the same property. Mr. Dubiaga stated that there are two issues in allowing the variances on this case:

- 1. Accessibility to the proposed second house for fire trucks and other emergency vehicles.
- 2. The subdividing of the parcel in the future will not comply with the current lot standards specified in the Trumbull County Subdivision Regulations.
