B. Farmington Township Comprehensive Plan

Mr. Kobak reported that the staff presented the final draft of the future land use map at the Trustees' meeting on November 18, 2015. He said that a review of the planning process timeline and community vision was discussed. He also said that the draft plan is scheduled to be unveiled to the trustees for discussion at their January 4, 2016, re-organizational meeting.

D. PY2015 Community Housing and Impact Preservation (CHIP) Grant

Julie Edwards reported that the staff has received the PY2015 \$250,000 CHIP Grant. She stated that the staff began taking applications on November 9, 2015, and reviewed over 25 applications.
