B. Champion Township Comprehensive Plan Update

C. Farmington Township Comprehensive Plan

Mr. Kobak stated that the community survey began distribution on February 4, 2015, and the staff continues to receive feedback. He said that the survey will remain open for two months and close on March 27, 2015.

D. Plats and Zoning Activities

Ms. Nuskievicz stated that the staff provides the administration of subdivisions which includes providing consultation services to landowners, and reviewing major and minor subdivisions to determine compliance with the Trumbull County Subdivision Regulations and other adopted plans. She stated that the administration also includes coordinating cross-agency reviews, preparing GIS maps, reports and providing recommendations to the Planning Commission Plats and Zoning Committee.

E. PY 2015 Community Housing and Impact Preservation (CHIP) Grant

Julie Edwards stated that she is in the process of applying for a PY2015 CHIP grant. She said that the amount of the grant is \$250,000 and is due by May 31, 2015. Ms. Edwards also reported that the Housing Advisory Committee (HAC) met on February 25, 2015, to identify gaps in housing services for the low-to-moderate-income population in Trumbull County and to recommend eligible CHIP activities that will increase services to that population. The HAC recommended that the eligible activities for the 2015 CHIP are Private-Owner Rehab, Home Repair and Home Repair-Septic.

Mr. Mahan made a motion to accept the Director's Report of March 10, 2015; seconded by Mr. Fuda. The motion carried.
