C. Farmington Township Comprehensive Plan

She stated that the signed contract was received by the Trumbull County Planning Commission on September 11, 2014. She said that the 19-month planning process is scheduled to begin in October 2014 and will be completed in April 2016.

D. CDBG Fair Housing Administration Program

Julie Edwards reported that the staff continues to administer the CDBG Fair Housing Program and has completed the FY2014 Fair Housing Program Plan that will run September 1, 2014, to December 31, 2015. Ms. Edwards said that the staff is working on an application for the New Horizon's Fair Housing Assistance Program which provides funds to units of local government to affirmatively further fair housing and eliminate impediments to fair housing. She said that these actions are in addition to a grantee's Standard Fair Housing Program.

E. USEPA Brownfield Assessment Grant

Ms. Nuskievicz reported that the Trumbull County Brownfield Coalition's current activities include conducting Phase I environmental assessments, asbestos survey assessments, urban setting designations, and developing and implementing a community engagement strategy.
