RE: AMENDMENT OF "CITIZEN PARTICIPATION POLICY" FOR TRUMBULL COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR PY2019/2020-AMENDMENT IS NECESSARY TO ALLOW VIRTUAL PUBLIC HEARINGS DUE TO COVID-19

MOTION: Made by Mr. Polivka, seconded by Mr. Cantalamessa, to approve an Amendment to the "CITIZEN PARTICIPATION POLICY" for the Trumbull County Community Development Block Grant Program for PY 2019 and 2020. The "Citizen Participation Policy" is a required element of the County's Community Development Block Grant (CDBG) Program. The Policy is currently in effect from September 1, 2019 through August 31, 2020. Due to concerns about significant public health risks, that may result from holding in person public hearings due to the ongoing COVID-19 Pandemic, therefore, Trumbull County will schedule and undertake virtual public hearings that allows questions in real time, with answers coming directly from public officials to all attendees via a Zoom Conference Call which will be publicized in the newspaper of general circulation, issues as a press release to local media outlets and shared with all local governments; this action per the recommendation of the Planning Commission and subject to review and approval of the Prosecutor's Office.


